# 5) Annual General Meeting October 3<sup>rd</sup>, 2016

Attending the AGM were 26 members representing 32 votes. 12 Proxies representing 19 votes were registered. The total vote count registered for the AGM was 51 of a total possible 74 votes from the total membership.

#### 6) Board of Directors / Audit Committee - Meetings

A total of 4 Board meetings were held during the period. One Audit Committee meetings was held during the period.

Jānis Loze resigned from the Board on December 16<sup>th</sup>, 2016.

Inta Cinīte (Inta Consulting) was invited to the Board as a non-voting member until the next elections.

## 7) Summary of activities

The Audit Committee Report was reviewed and corrective measures were taken in order to achieve compliance.

A new contract was signed with "TP Riga" for Indra Sproģe-Kalviņa to continue responsibles for bookkeeping and administrative services as per the budget approved by the AGM.

Statute changes: Statutes were modified to meet current requirements. Because of the number of changes, the new variant is being offered by the Board for consideration of the membership. The current statutes are in the web site at http://cancham.lv/about-cancham/statutes.

Guidelines for an Ethics Committee were provided by Guna Skangale in Latvian, but the Board was not able to action this issue.

The concept of "SELL SHEETS" was introduced in order for members and the public to better understand what out members have to offer. See <a href="http://cancham.lv/services">http://cancham.lv/services</a>. This is still in the development process.

The CanCham started to use FB Workplace in order to enhance communication between the various groups in the CanCham. This is at the development stage.

The CanCham is organizing a business reception and presentation of CanCham and its members in Toronto, Canada on September 19<sup>th</sup> with the intent of establishing strategic partnerships between members and the Canadian business community.
