2.1.2 Compensation issues / Sustainability

 171005 KS - Remuneration for bookkeeping and administrative services: Karlis Sarkans. Since its establishment at the 2017 AGM, the committee consisting of three members and headed by K. Sarkans has not shown any initiative in exploring the remuneration issue. At this Board meeting, Henrik Mjoman assumed responsibility for conducting research and proposing options for review.

2.2 Policies

- 2.2.1 The new Privacy and Personal Data Policy (see http://cancham.lv/about-cancham/privacy-and-personal-data-policy) was accepted on 27.05.2018 by EK, HM, IC.
- 2.2.2 A policy on Membership fees for Members with more than one company/logo was approved on 22.02.2018 by EK, IC, HM and ISK. This policy states that the CanCham offer the following
 - a. A group of related companies may be represented in the CanCham as a Senior Corporate member. One of their logos would have Senior Corporate member status, the others would be in the Corporate level.
 - b. A group of related companies may be represented in the CanCham as a Corporate member. One of their logos would have Corporate member status, the others would be in the Business level.

2.3 Business Development

- 2.3.1 Mission to Latvia planned for March 29th to April 8th was cancelled due to lack of interest.
- 2.3.2 Mission to Canada planned for May 9th to May 17th was cancelled due to lack of interest.

2.3.4 Other business development options

- Strategy change
 - work with individuals/companies in Canada and internationally who are interested in working with the CanCham, with a focus on partnership development. For example, EK will have a discussion with a business person from India about collaboration between CanCham and Indian businesses.

4.4 Membership Levels

- 4.4.1 171030 Board: Review of membership categories and associated fees- further discussion required.
- 4.4.2 171030 AG: Dealing with non-paying members: Arvids offered to create an automated system that would alert the administrator of the due date and issue invoices. Ed Kalvins agreed to work on this system. As of now, AG is working on such a system.

4.5 Work groups
