# 5) Strategic review

CanCham's immediate objective after the re-start in early January 2024 was identified as being to support Canadian business initiatives in Latvia and those of the Canadian led Task Force Latvia by assisting them to connect to local Latvian service and equipment providers through in-person CanCham networking events that provide for personal contact and the establishment of business relationships.

Business focused networking events including the following were deemed to be useful in meeting this objective:

- "CanCham Corner" informal get-togethers just to relax and chat, enjoy good food and strengthen relationships with business partners.
- Core Events such as Canada Day, the Canadian Thanksgiving and CanCham Christmas.
- Events with visitors from Canada or local specialists.
- Business breakfasts and lunches.
- "Show & Tell" provides members with the opportunity to present their businesses to others.
- Seminars and "CanCham Talks" provide information sharing opportunities for relevant issues.

The CanCham Strategy published September 11<sup>th</sup>, 2022 will be revisited with the intention of avoiding some of the shortfalls experienced in the past.
