## Latvia and Canada in trade

Total trade turnover in goods and services – 312,2 MEUR(2020)

Latvian export – 43, 8 MEUR
Canadian export – 268, 4 MEUR


Canada is the 22nd largest trade partner.

Our bilateral trade to a great extent is driven by airBaltic purchases of Canadian-made Airbus aircrafts A220-300.

Till 2023 airBaltic will buy 50 more aircrafts. In the past couple of years, the value of the imported aircrafts Airbus to Latvia has exceeded EUR 1 billon (95% of Canadian import to Latvia).

Canada is Latvia's 45th export market.

#### Embassy's work to promote trade relations

Very important is to promote awareness of the benefits of CETA.

# Export priorities

#### Six smart sectors defined by the Latvian government:

- biomedicine
- bio economy
- smart energy (green technologies, renewable energy, solar, wind, hydrogen)
- smart materials (including photonics and optics)
- ICT one of the fastest- growing industry in Latvia (5G)
- Smart cities (VEF Innovation district)

Perfect match for **Canada's priority sectors:** green energy, bio economy, waste recycling.



# Embassy's priorities

- To support trade missions to Canada (major trade fairs: Toronto, Montreal, Ottawa) in close cooperation with Latvian Investment Agency (LIAA) and Canadian Embassy in Riga.
- To iniciate a cooperation between Latvian Chamber of Commerce and Industry (LTRK) and provincial chambers of commerce (Ontario Chamber of Commerce in 2021).
- To iniciate a cooperation between Latvian ICT industry and 5G Canada Council.
- In line with Latvia's Tourism and Marketing Strategy 2018-2023, to promote the influx of tourists to Latvia. Embassy participates in the International tourism exhibition in Montreal, November 5-7, 2021.



**CETA** EU-Canada Comprehensive Economic and Trade Agreement

Following the signature, the consent by the European Parliament and the ratification by Canada, CETA applies provisionally since 21 September 2017, waiting its ratification by all European Union member states (so far, 16 countries have ratifed it).

Latvia is the first EU country ratified CETA.

The Latvian parliament (Saeima) ratified CETA on 23 February 2017.



**CETA benefits for Latvian business** 

- Scrapping customs tariffs for Latvian exporters and importers
- Opening up the Canadian services market to Latvian firms
- Enabling Latvian firms to bid for more public contracts in Canada
- Protecting Latvia's research and creativity
- Making it easier for Latvian professionals to work in Canada
- Encouraging more investment between Latvia and Canada
- Helping Latvia's small business export more to Canada
